Bank OZK (the “Company”) announced that it has entered into a settlement agreement with respect to a previously disclosed securities class action lawsuit commenced in 2018, captioned Strathclyde Pension Fund v. Bank OZK, et al., case number 4:18-cv-793-DPM. The settlement is subject to court approval and does not include or constitute an admission, concession, or finding of any fault, liability, or wrongdoing by the Company or any defendant. If the court approves the settlement, the Company expects that the full amount of the settlement will be paid by the Company’s insurance carriers under applicable insurance policies.
