



### Bank of the Ozarks Subsidiaries: HOJ Equities, LLC; 318 Cadiz Holding, LP; 318 Cadiz CP, LLC

Bank of the Ozarks ("BOTO") in August 2009 formed a wholly owned subsidiary HOJ Equities, LLC ("HOJ"; a Texas limited liability company) to accept all of the ownership interests in 318 Cadiz, LP ("Borrowing Entity"). Specifically, HOJ acquired 100% of 318 Cadiz Holding, LP ("Holding"; the owner of 99% interest in the Borrowing Entity) and 318 Cadiz GP, LLC ("GP"; the owner of 1% interest in the Borrowing Entity).

To provide more detail, the Borrowing Entity is a single-asset entity, which holds fee title to approximately 60 acres of land in Dallas, Texas. Due to BOTO's desire to protect certain valuable development rights (which are specific to the Borrowing Entity), BOTO directly acquired all of the interests in Holding and GP. The only asset of both of these entities is their respective interests in the Borrowing Entity. As noted in the attached Exhibit, HOJ, Holdings and GP are nominee entities, which will all be rolled-up (and ignored for tax purposes) into BOTO.
